WELCOME NEW MEMBERS

President Renninger welcomed new Board Members: City of St. Augustine Beach Commissioner Virginia Morgan.

INVITATION TO SPEAK

President Renninger stated that members of the public are welcome to speak on any item before the Board and will be recognized during public comment.

*CONSENT AGENDA

Mr. Register motioned to approve the Consent Agenda; seconded by Commissioner Harvey. Motion carried unanimously.

OTHER REPORTS/ACTION ITEMS

NEFRC Financial Structure

Ms. Starling provided an overview of the Council's financial structure highlighting the fiscal year is from October to September; the Council is a governmental agency formed by State Statute Chapter 186 and created by interlocal agreement with our Member Counties; and receives funding from State, Federal and Local governments. She shared information on the Council's accounting guidance that the Council follows for federal and state awards; internal policies are aligned with the State of Florida policies; State Statute allows governmental agencies to contract with the Council without having to go through the RFP process. Additionally, per the interlocal agreement, the Council Board must approve the annual budget by July 15th for operation on October 1st. There is usually a mid-year budget amendment around June of each year. Ms. Starling also shared the source percentage of the budget for FY 23/24 and FY 24/25; the county dues received from member counties are based on \$0.41per capita; Federal and State funding sources; and the role of the Personnel, Budget and Finance Committee.

*<u>FY 23/24 Audit</u>

Mr. Chalifour presented the FY 23/24 Audit. He highlighted the audit process that includes, 1) the required communications in a financial audit scope with the objective of expressing an opinion on the financial statements in terms of the numbers, 2) audit reports on the financial statement and the compliance for federal programs, both received unmodified opinions, and no material weaknesses observed on the internal control and compliance report. He stated that the Council is in a strong financial position with a reserve of approximately \$2.6 million. A brief discussion followed.

President Renninger called for a motion on the FY 23/24 Audit. Mr. Register motioned to approve the FY 23/24 Audit; seconded by Commissioner Martin. Motion carried unanimously.

*<u>NEFRC Fiscal Year 23/24 Closeout</u>

Ms. Starling provided an overview of the Council's FY 23/24 budget reconciliation and closeout. She stated that the Council began with an adopted budget of approximately \$3,289 million and ended with \$3,197 million; producing a revenue reduction of approximately \$91,000. She stated there was also a reduction in the expenses of approximately \$88,000. A brief discussion ensued.

President Renninger called for a motion on the NEFRC FY 23/24 Closeout. Commissioner Harvey motioned to approve the FY 23/24 Closeout; seconded by Mr. Register. Motion carried unanimously.

Military Installation Resilience Presentation

Mr. Mark McManus, Naval Air Station & Naval Station Mayport Community Planning and Liaison Officer provided a presentation on Navy military installations in Jacksonville. Mr. McManus informed the Members of the change in the name of the grant, now to be called 'Military Installation Readiness Review' going forward. He stated that the purpose of this study is a holistic look between the Base and the surrounding communities. His presentation highlighted the military's impact on the local area including an overview of NS Mayport and NAS Jacksonville, and the local training ranges. In conclusion, he stated that the MIRR will analyze the vulnerabilities and risks and identify projects that can mitigate those challenges. . Discussion ensued.

Commissioner Bennett left the meeting.

*RFP: Military Installation Readiness Review

Ms. Payne provided the Members with background information on the Military Installation Readiness Review (MIRR) request for proposal process. She stated that staff received three proposals: Jacobs Engineering, Stantec Consulting's Services Inc., and Tetra Tech that were reviewed and ranked by a committee comprised of herself, Fara Ilami (NEFRC Regional Resiliency Manager), Donna Starling (NEFRC Chief Financial Officer), James Richardson (City of Jacksonville's Environmental Protection Board), and Chief David Motes (Clay County Fire Chief). Based on the Committee's review and rankings, Jacobs Engineering was ranked highest. Discussion followed regarding following State guidelines regarding any protests.

Chair Register motioned, on behalf of the Personnel, Budget & Finance Committee, that the CEO be authorized to enter into negotiations of terms with the top scoring firm, Jacobs Engineering; seconded by Councilmember Amaro. Motion carried.

Community Resiliency Update

Ms. Ilami provided an overview of the Council's current resiliency activities in the Region including the Military Installation Readiness Review, and the Regional Resilience Entity project. She also provided information on multi-regional efforts taking place in several counties, and technical assistance provided to local governments. Discussion ensued.

President Renninger indicated that the Resilient First Coast Steering Committee needs a Board representative and asked for a volunteer. **Commissioners Minshew and Murphy volunteered to serve. Commissioner Dance also expressed an interest.**

Program Spotlight: Strategic Regional Policy Plan Review-Part 2

Ms. Payne provided an overview of the Council's Strategic Regional Policy Plan (SRPP), and the process involved in revising the Plan every five years. She stated in November 2024 the Council Board approved the 2024 SRPP Plan Assessment and authorized staff to begin the SRPP update. She stated that the Rulemaking process goes through 2026 when it will be brought back to the Board for approval. The remaining four elements and recommendations are provided for your review reflecting staff's proposed changes in track changes shown as strikethrough and underlined for **Element**: Energy; **Determination**: Delete this element – it is not a required element, and the Council has no role in the implementation of these objectives. **Element**: Health; **Determination**: Delete this element – it is not a required of Regional Significance; **Determination**: Keep – recommended changes shown as strikethrough and underlined. **Element**: Regional Transportation; **Determination**: Keep – recommended changes shown as strikethrough and underlined. The remaining elements – Cultivation and Resilience – will be brought to a future meeting.

EDA Funding: Post Disaster Recovery for Hurricanes Helene & Milton

Ms. Payne stated that the Council is the Designated Economic Development District of the U.S. Economic Development Administration (EDA) for our region. She informed the Members that the Council received \$500,000 from the EDA to fund disaster recovery following Hurricanes Milton and Helene over the next four years, She stated a Listening Session will take place in St. Johns County next week with federal agencies and local governments to discuss the 2024 season impacts, unmet needs, and potential project funding opportunities. Ms. Payne added that the Council will utilize some of this funding to establish a new initiative, the Community Visioning Program.

Ms. Dominguez shared information on some of staff's recent visioning work and the benefits. The Community Visioning Program will target smaller local governments/municipalities lacking the financial resources or staff to do the work. Thereby increasing their ability to plan for long-term recovery and resilience. Staff is currently seeking participants for the program. A brief discussion ensued.

Public Comment

Mr. John J. Nooney, 8356 Bascom Rd., Jacksonville, FL 32216, representing NEFRC – public park on Pottsburg Creek in Duval County and public access to our waterways. He participated in the Resilient Jacksonville and believed the biggest takeaway is that 90 percent of the waterways in Jacksonville is private with only ten percent of the waterway being public. He also shared his thoughts on the Department of Elder Affairs and senior citizens centers, disability etc.

Local and Regional Issues Discussion

St. Johns County – **Commissioner Joseph** stated there will be an ad during the Superbowl representing their farmers. Lays Potato Chips put the ad out and included the family that grows the potatoes in St. Johns County for the chips in the ad.

Clay County – **President Renninger** complemented the Council for their collaborative efforts.

EX-OFFICIO MEMBERS' REPORT

<u>Florida Commerce</u> – Mr. Register shared information from an article in Site Selection Magazine regarding a survey of approximately 200 CEOs of companies that recently relocated or expanded and ranked the top 25 States based on business climate. The survey placed Florida fifth in the ranking; Texas was first, Georgia was second, NC was third and Virginia was fourth. He also shared some of the reasons these CEOs make the choices they made.

<u>Department of Environmental Protection</u> – Ms. Craver stated that DEP will be hosting their Environmental Resource Permitting Workshop series. The first workshop is scheduled for February 19th and will then be quarterly throughout 2025.

<u>St. Johns River Water Management District</u> – Mr. Conkey reminded the Members that lawn watering is once per week. He added the SRPP page 3G-11, the Black Creek project is wrapping up and should be up and running by Summer.

CHIEF EXECUTIVE OFFICER'S REPORT

Ms. Payne introduced the Council's Emergency Management Intern, Mr. Kyle Higginbotham.

Mr. Nolen, Local Emergency Planning Committee Coordinator, worked with CSX to get their Responder Incident Training train in our region at the Baldwin Railyard February 11-14 for HazMat Technician training. On February 13th interested elected officials can attend and observe the training.

Legislative priorities have been printed and available at today's meeting. Additionally, Council staff will be taking copies to each County BOCC meeting for distribution.

The Florida Regional Councils Association (FRCA), an association of the ten regional councils in the State of Florida, held a Policy Board meeting in January; President Renninger and Mr. Register serve on the Board. A copy of the FRCA Annual Report, covering the activities of all the Councils statewide is available for you.

Trails meetings are being held in each county, with Jacksonville, Nassau, and St. Johns taking place in the next few weeks.

The Council now has an attorney in place, Mr. Jeremiah Blocker of the Douglas Law Firm. Mr. Blocker plans to attend future meetings as needed.

The audit was approved by the Board at its February 6, 2025 meeting. Per Reserve Policy #2-34 (attached), the Personnel, Budget and Finance Committee will review and approve funds to be transferred to reserves based on the Council's audited net income from the previous fiscal year. The audited net income for fiscal year 2023/2024 was \$88,896. The goal set forth in the policy is to transfer 15% to 20% to reserves. Below is the possible transfer amount based on the Council's goal.

POLICY: Northeast Florida Regional Council Reserve Policy

PURPOSE: Reserves are meant to address unexpected costs that would adversely affect operating cash balances. Reserves will also be used to assist with the payment of the Florida Division of Retirement Pension Liability, should all or portions of said liability (excluding normal contributions based on payroll) become due at a future date.

PROCEDURES:

- 1. The Council's goal is to maintain a minimum of three months of operating expenditures in reserves, based on the Council's unrestricted (assigned plus unassigned) fund balance relative to annual operating expenditures.
- 2. The Council will strive to transfer 15% to 20% annually of the previous fiscal year's audited net income (defined as the change in fund balance in the general fund) to reserves. The amount to be transferred will be reviewed and approved by the Personnel, Budget, and Finance Committee.
- 3. If the Council incurs an audited net loss for a given fiscal year, no funds will be transferred to reserves for that year unless authorized by the Personnel, Budget, and Finance Committee.
- 4. Reserves shall be used to:
 - A. Pay for unexpected costs that would adversely affect operating cash balances.
 - B. Assist with the payment of the Florida Division of Retirement Pension Liability, should the liability become due at a future date.
- 5. If the use of reserves is necessary, prior approval by the Council Board of Directors will be required unless previously authorized by the Council Board of Directors as part of the approved annual budget.

- 6. If reserves are needed for emergency expenditures, the Council Board President can approve the use of reserves. Ratification of the approval for such expenditures shall be contemplated at the subsequent Council Board meeting.
- 7. If reserves fall below the minimum amount as set forth by this policy, management shall draft a plan to restore reserves to the minimum amount and present such plan at the subsequent Council Board meeting.

RE: LOCAL GOVERNMENT COMPREHENSIVE PLAN AMENDMENT REVIEWS

Pursuant to Section 163.3184, Florida Statutes, Council review of transmitted and adopted amendments to local government comprehensive plans is limited to adverse effects on regional resources and facilities identified in the Strategic Regional Policy Plan (SRPP). The review is also limited to extra-jurisdictional impacts that are inconsistent with the comprehensive plan of any local government within the region. Pursuant to Section 163.3184, Florida Statutes, a written report with an impact evaluation should be provided to the local government and the State land planning agency (Florida Commerce) within 30 calendar days of receipt (of the amendment).

A regional map of the listed amendments is provided on the next page, and the site-specific maps and policy texts are provided in the appendix herein. Upon approval of this report by the Northeast Florida Regional Council (NEFRC) Board of Directors for transmittal to the State land planning agency, a copy will be provided to the respective local government.

The following amendments are provided for information only since the NEFRC provided technical assistance. These include the Town of Beverly Beach Transmitted Amendment 25-1ESR, the Town of Callahan Adopted Amendment 24-1ESR, and Putnam County Adopted Amendment 24-1ER. The Board's approval is required only for the first four amendments.


Recommendation

Staff respectfully recommend the NEFRC Board of Directors approve the staff review report for the City of Jacksonville Transmitted Amendment 25-1ESR and the City of Crescent City Transmitted Amendment 25-1ESR.

Staff also recommend the NEFRC Board of Directors find the City of Jacksonville Adopted Amendments 24-3ESR and 24-5ESR consistent with the Strategic Regional Policy Plan.

• **Type:** Future Land Use

- **Issue:** This adopted future land use map amendment changed approximately 1,004 acres from Multi-Use pursuant to Future Land Use Element Policy (FLUE) 4.3.15. and Light Industrial to Conservation, Light Industrial, Community General Commercial, Medium Density Residential, and Low Density Residential.
- **Background:** The approximately 1,004-acre subject site is undeveloped land located in the North Planning District. The site is located at Pecan Park Road, a collector road, and Main Street North (U.S. 17), a Florida Department of Transportation (FDOT) Principal Arterial. The site is between Interstate 95 and Main Street North. The subject property is located within the Suburban and Rural Development Areas. The applicant is requesting an extension of the Suburban Development Area to cover the entirety of the subject site. A companion PUD application has been filed and is moving concurrently with this amendment. For additional information, please see Exhibit 1-2 in the appendix. The Site-Specific FLUE Policy 4.3.15. is no longer relevant and has been removed by this amendment.
- **Impacts:** The subject site is located on Pecan Road and U.S. 17, both Transportation Resources of Regional Significance. Based on a trip generation estimate during the transmittal phase comparing the previous and then proposed comprehensive plan land uses and the potential impacts on the roadway network, the development had the potential to increase daily trips between 8,741 to 12,696. The Jacksonville Transportation Planning Division recommends ongoing coordination of efforts with the City of Jacksonville Transportation Engineer and the Florida Department of Transportation to ensure that a traffic operational analysis is provided to address the specific external impacts as a result of this land use amendment. The Florida Department of Transportation recommended a multi-modal transportation impact analysis to ensure the state facilities operate at an appropriate level of service. The companion Planned Unit Development (PUD) rezoning, Ordinance 2024-971-E, requires a condition that a traffic study be provided at Civil Site Plan Review that will meet the requirements of the Land Development Procedures Manual and that additional traffic studies may be required of individual developments inside the PUD. The site is also located within the 300-foot and 150-foot height and hazard zone of the Jacksonville International Airport, a Transportation Resource of Regional Significance. Zoning will limit the development to a maximum height of 300 or 150 feet, respectively, unless approved by the Jacksonville Aviation Authority or the Federal Aviation Administration.
- **Recommended Intergovernmental Coordination:** Considering the proximity of the subject site to Nassau County, the NEFRC recommended that the City coordinate with the Nassau County Planning Department regarding this proposed amendment. The City's Planning and Development Department emailed the information regarding the proposed information to the Nassau County Planning Department on September 10, 2024. The Nassau County Planning Department responded in an email dated September 11, 2024, that they received the information and will get back to us with any questions.

- Type: Text
- Issue: This adopted amendment changed the text for the Business Park (BP) and Light Industrial (LI) land use categories of the Future Land Use Element (FLUE) of the 2045 Comprehensive Plan.
- **Background:** Industrial uses in the BP and LI categories must be conducted within an enclosed building. The Industrial categories of the FLUE allow for some commercial uses. The amendment includes a change to the General Intent sections of the BP and LI land use categories to clarify commercial retail sales and service uses do not need to be conducted within an enclosed building in the BP and LI land use categories. This will accommodate seasonal outside sales, outside seating, etc.

The principal uses of the LI land use category have also been modified to specifically include the storage of flammable and combustible products and products not deemed extremely hazardous. The companion changes to the Light Industrial Zoning District (Ordinance 2024-618) mirror the text amendment to the LI Land Use Category and limit the amount of these types of products not to exceed 250,000 gallons. Please see Exhibit 3 in the Appendix for additional information.

- **Impacts:** There were no impacts to Resources of Regional Significance or extra-jurisdictional impacts that would be inconsistent with the Comprehensive Plan of an affected local government identified by Staff.
- **Recommended Intergovernmental Coordination:** Considering that this is a text amendment to the City's Comprehensive Plan, no intergovernmental coordination is recommended by Staff.

- Issue: This is a proposed amendment to the Conservation and Coastal Management Element (CCME) and the Infrastructure Element (IE) of the 2045 Comprehensive Plan of the City of Jacksonville to enact, by reference, the State Mandated ten (10) year Water Supply Facilities Work Plan.
- **Background:** Ordinance 2024-969 adopts a text amendment to amend Policy 2.12.2 of the Conservation Coastal Management Element and Policy 1.1.13 of the Infrastructure Element, Potable Water Sub-Element of the 2045 Comprehensive Plan to enact by reference the state-mandated 10-year water supply facilities work plan pursuant to Section 163.1377(6)(c)(4), Florida Statutes. The statute encourages local governments to cooperatively plan for the development of multijurisdictional water supply facilities that are sufficient to meet projected demands for established planning periods, including the development of alternative water supplement traditional sources of groundwater and surface water supplies.

The Water Supply Facilities Work Plan (WSFWP) includes an evaluation of the present and projected growth and water demand as well as an analysis of the existing production/treatment facilities and their capacities to meet the City's existing and projected water demands for a 10-year planning period, 2024-2034. To this end, the amendment to the IE, Potable Water Sub-Element Policy 1.1.13 adopts the City of Jacksonville 2024-2034 WSFWP by reference into the Comprehensive Plan, and the amendment to CCME Policy 2.12.2 reflects the end date of the WSFP's planning timeframe. The Planning and Development Department coordinated with the JEA and the St. Johns River Water Management District to update the WSFWP and the associated text amendments to provide compliance with the Florida Statutes.

- **Impacts:** There were no impacts to Resources of Regional Significance or extra-jurisdictional impacts that would be inconsistent with the Comprehensive Plan of an affected local government identified by Staff.
- **Recommended Intergovernmental Coordination:** Considering that this is a text amendment to the City's Comprehensive Plan, no intergovernmental coordination is recommended by Staff.

- **Background:** The proposed comprehensive plan amendment to the Water Supply Facilities Work Plan contained within the Public Facilities Element meets the requirements of Chapter 163.3177 and extends the plan from 2038 to 2045 for long-range planning purposes. Policy D.2.3.2 of the Comprehensive Plan has been updated to reflect a date change consistent with the updated Water Supply Facilities Work Plan. 



Exhibit 1: City of Jacksonville 24-3ESR (Location Map)

BUSINESS PARK (BP) BP - GENERAL INTENT

Business Park (BP) is a category primarily intended to accommodate business offices and low intensity light industrial uses. Uses, <u>except for with the exception of commercial retail</u> <u>sales or service and</u> ancillary and accessory outside storage uses, shall be conducted within an enclosed building. Business offices should comprise the majority of the category land area, while service, major institutional and light industrial uses constitute the remaining land area. Limited commercial retail and service establishments, hotels, and motels may also be permitted. Residential uses are also permitted in appropriate locations as identified under the Development Area Uses and densities. Development within the category should be compact and connected and should support multi-modal transportation. Uses should generally be designed in a manner which emphasizes the use of transit, bicycle, and pedestrian mobility, ease of access between neighboring uses, and compatibility with adjacent residential neighborhoods. Transit- Oriented Developments (TOD), as defined in this element, are encouraged when in close proximity to an existing or planned JTA premium transit station. Density, location and mix of uses shall be pursuant to the Development Areas as set forth herein.

LIGHT INDUSTRIAL (LI)

<u>LI - GENERAL INTENT</u>

Light Industrial (LI) is a category which provides for the location of industrial uses that are able to be performed in such a manner as to control the external effects of the process, such as smoke, noise, soot, dirt, vibration, odor, etc. Uses within this category, other than outside storage <u>and retail sales and service</u>, shall be conducted within an enclosed building. Generally, light industrial uses involve materials that have previously been prepared, or raw materials that do not need refining. These uses do not create a noticeable amount of noise, dust, odor, smoke, glare or vibration outside of the building

or on the site in which the activity takes place.

Site access to roads classified as collector or higher on the Highway Functional Classification Map is preferred; except for sites located within the DIA's jurisdictional boundaries.

<u>LI - GENERAL USES</u>

The uses provided herein shall be applicable to all LI sites in all Development Areas and uses, other than outside storage, shall be conducted within an enclosed building.

Principal Uses

Light assembly and manufacturing; Packaging; Processing; Manufacturing of paints, enamels and allied products; Concrete batching plants; Storage/warehousing, including storage of flammable and combustible products and products not deemed extremely hazardous; Distribution; Research and development activities; Transportation terminals; Radio/T.V. studios; Transmission and relay towers; Yard waste composting; Recycling facilities; Offices; Medical clinics; Veterinary offices; and Vocational/trade schools and building trade contractors.

Existing dwellings which were legally built as single or multi-family dwellings prior to the adoption of the 2010 Comprehensive Plan shall be allowed as a legal, non-conforming uses and may be rebuilt if necessary so long as the original structure and density is not intensified or enlarged in any way, as long a_s there is not an adopted Neighborhood Action Plan and/or study recommending against them.

Secondary Uses

All public facilities and non-residential uses permitted in residential and commercial land use categories may also be permitted as secondary uses.

In addition, the following secondary uses may also be permitted: Railroad yards; Truck terminals; Bus and rail stations; Solid waste management facilities including composting and recycling operations; Institutional uses and public facilities; Utility plants and facilities; Broadcasting studios including transmitters; and Telephone and cellular phone towers.


Key Definitions & Governing Statues of Program

Florida State Legislature created the Transportation Disadvantaged Commission (CTD) and Transportation Disadvantaged (TD) Trust Fund in 1989.

What is Transportation Disadvantaged?

- "Transportation disadvantaged" means those persons who because of physical or mental disability, income status, or age are unable to transport themselves or to purchase transportation and are, therefore, dependent upon others to obtain access to health care, employment, education, shopping, social activities, or other lifesustaining activities, or children who are handicapped or high-risk or at-risk as defined in s. 411.202. (F,S)" 427.011 (F,S)
- The Transportation Disadvantaged Program is a coordinated state-wide effort that groups riders together for a shared ride service. Transportation services are available in all 67 Florida counties for those who are eligible and have no access to transportation. Federal, State, and Local agencies join together to provide necessary transportation to medical appointments, employment, educational, and other life-sustaining services.
- Florida State Statue 427.011-427.017
- Florida State Administrative Code 41-2





Commission for the Transportation Disadvantaged (CTD)

The Commission for the Transportation Disadvantaged (CTD) oversees the coordination of TD services across Florida's 67 counties. The CTD is made up of a 7-member governor-appointed board, with 8 ex-officio members, representing purchasing agencies, and staff that monitors activity at a regional level.

Responsibilities

- Approves the designation of every CTC at least every five years.
- Administers the TD Trust Fund, including the awarding of grants.
- Reviews and approves Commission publications, including the Annual Performance Report.
- Develops/approves policies governing coordinated transportation (e.g., rules, procedures, etc.).
- Participates in professional development events, including an annual training workshop.
- Appoints and oversees Executive Director.





Designated Official Planning Agency (DOPA)

The Northeast Florida Regional Council has proudly served as the CTD designated official planning agency for Baker, Clay, Flagler, Nassau, St. Johns, and Putnam since 1994. The Council was made the designated planning agency for Duval county in 2021.

Responsibilities

- Assist the Community Transportation Coordinator and Local Coordinating Board in the implementation of local Transportation Disadvantaged program(s).
- Staffs Local Coordinating Board.
- Appoints members to Local Coordinating Board(s).
- Procures and recommends Community Transportation Coordinator.
- Coordinates and conducts transportation planning activities for its service area.

Local Coordinating Board (LCB) Continued

The LCB meets quarterly and provides guidance on local coordination of transportation services.

Responsibilities

- Assists in establishing eligibility guidelines and trip priorities.
- Assist with the development of the TD Service Plan.
- Evaluates the performance of CTC.
- Identifies and prioritizes local service needs.
- Appoints a grievance committee.
- Reviews and recommends other funding applications.
- Reviews strategies of service provision to the area.
- Evaluates local and regional transportation opportunities.

RE: COUNCIL 101: STRUCTURE

In 2025, each Board of Directors meeting agenda will include an overview of a component of the NEFRC to educate new members and reacquaint long serving members. This month's '*Council 101*' is an overview of the structure of the NEFRC, including Florida Statute references, Board appointments, rotation of leadership, and committees.

Creation

A regional planning council is created under the authority of Section 186.504, Florida Statutes, with the formal organization being formed under authority of Section 163.01, Florida Statutes, pursuant to a properly executed interlocal agreement.

The seven counties of Baker, Clay, Duval, Flagler, Nassau, Putnam and St. Johns counties signed an interlocal agreement (ILA) to form NEFRC in 1977. The most recent version of the ILA is from 2003.

- (a) Each member government shall have four (4) appointed representatives of which at least three (3) shall be locally appointed representatives, including, two (2) of which shall be elected representatives of the governing body of each of the member governments; however, each member government shall have the option of appointing a person who resided within the boundaries of the member government to represent one of the positions who is not an elected representative of the governing body; one (1) of which shall be an elected municipal representative of a participating member unit from each member government; however, each municipality which is represented shall have the option of recommending a person who resides within the boundaries of the municipality to represent them who is not an elected municipal representative. No less than one (1) additional representative from each member government who shall be a gubernatorial appointee, pursuant to Section 186.504 Florida Statutes. The total number of appointed representatives of the COUNCIL shall be thirty-one (31) inclusive of the ten-(10) gubernatorial appointees.
- (b) Municipal representatives from the participating member units shall be appointed by the governing body of the member government. The municipal representative shall be appointed from among the recommendations provided by the governing bodies of each municipality making such recommendation. In any event, the appointment of municipal representative from each member government shall be at the sole discretion of the governing body of member government.

Membership – defined by the interlocal agreement

Interlocal also:

Establishes the officers of the Council

Establishes the meeting schedule

Defines the fiscal year – October 1 to September 30

Requires an annual budget to be adopted on or before July 15 each year

Allows the Council to receive grants and funding from other sources

Leadership Restructure

- Amended to include Clay County as of FY21-22 in December 2021.
- In December 2019, the Board approved a restructure of leadership. This included:
 - Established a rotation of leadership by County.
 - The 2nd Vice President is now a standing position (not in ascension order to President) and filled each year by a Duval County/City of Jacksonville member.

Elizabeth Backe, Nassau County Planning Director, will provide an update on the Nassau Florida Vision 2050 program.










Project Background


- The City of St. Augustine needed to update its 2014 and Beyond Vision Plan




RE: BLACK HISTORY MUSEUM

The City of St. Augustine in St. Johns County was selected as the top location for the Black History Museum in 2024 by a statewide taskforce. Mr. Howard Holley, representing the newly formed Foundation for the Museum of Black History, will provide an update on the museum and the follow-up work needed in the coming year.









Executive Summary

- On May 11, 2023, Governor DeSantis signed CS/CS/HB 1441 establishing the Florida Museum of Black History Task Force.
- The task force was created to recommend the planning, construction, operation, and administration of the proposed museum.
- Task Force Composition: 9 members, including legislators, business & community leaders, and educators.
- 13 submissions were received statewide, narrowed to three finalists: Eatonville/Orange County, Opa-locka/Miami-Dade County, and St. Augustine/St. Johns County
- St. Augustine/St. Johns' West Augustine was recommended to the Governor and the Legislature as the museum site

Site Selection Criteria

- Historical Significance of St Augustine/St Johns: Over 450 years of Black History. First Free Black Settlement in US, Fort Mose
- Appropriateness of Location: Historical West Augustine & Former Campus of Florida Memorial College – HBCU
- Regional Economy: St Johns is the 4th fastest-growing county in the US.
- Demographics: Northeast region: 1.5M population and 16% Black
- Transportation Infrastructure: Location: 2.5 miles from city center. Accessibility to all of Florida & US Southeast Region
- Funding Commitments: Broad Statewide, Regional, and Local support!
- Educational Resources: Top FL ranking for 30+ years. Flagler College, St Johns River State College, UNF & UF


1. Eight (8) page summary document of the application was produced by St Johns County.

2. The Black Museum was submitted as a Legislative Priority by St. Johns County, St Johns Chamber of Commerce, and NEFRC.


3. The Foundation, established in November 2023, will support the planning, design, and engineering of the Museum, while also overseeing communications, fundraising, and community engagement efforts.

4. On February 3, 2025, Senator Leek filed bill SB466 formalizing St. Augustine/St. Johns as the museum's location and creating a new Task Force.

5. Legislative Bill HB0659 was filed in the Florida House by Rep. Kiyan Michael along with \$2Million in Earmarked Funds for Planning Design and Engineering (PD&E) Phase I

The Northeast Florida Local Emergency Planning Committee (LEPC) for Hazardous Materials Program is funded through a contract with the Florida Division of Emergency Management. The LEPC has reached the midpoint of its FY 24-25 contract. Thus far, the committee has successfully provided multiple training opportunities for the Region, with several more scheduled for the remainder of the fiscal year.

Additionally, following insights gained from an after-action report of a recent training exercise with CSX, the LEPC has received provisional approval to purchase leak control kits for the Region, further enhancing response capabilities.

The LEPC remains committed to expanding training opportunities and strengthening regional preparedness for hazardous materials incidents throughout the remainder of the fiscal year.

Florida's Implementation of SARA Title 3

Florida passed its **own EPCRA legislation in 1988**

SERC is staffed by Florida Division of Emergency Management and LEPCs are separated into 10 regions (housed within Regional Councils)

LEPCs maintain 3 separate contracts

- 2. Hazards Analysis
- 3. Hazardous Materials Emergency Preparedness Grant (HMEP)
